Haywood-Arpelar FD and Pittsburg County wish to advertise for the following:

One used 1999 or newer commerical pumper with four door cab with seating for five (5) with four (4) Scba seats. Truck must have 330 HP engine with Allison HD4060 automatic transmission (or equivalent) with 29,709 miles or less and 1900 engine hours or less. Apparatus will not be longer than thirty-one feet (31) with a wheel base of two-hundred and fifty inches (250). Height of truck will be eight foot, nine inches or less (8'9") with GVWR of thirty-five thousand (35,000). Apparatus must have air-conditioning. Apparatus will come with all maintenance records and manuals. Apparatus must come with emergency lighting and wheel simulators.
