WHEREAS, each competitive bid submitted to the County must be accompanied with an affidavit for filing with the competitive bid form as required by 61 O.S. § 138.

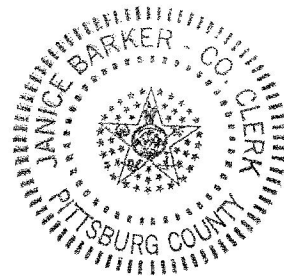

Striping to include approximately six (6) miles of DOUBLE YELLOW centerline with approximately six (6) miles of WHITE edge lines on both sides.

Company awarded bid is required to locate and "string line" center of road for maximum accuracy.
