SPEC SHEET FOR TANNEHILL BUILDING AT SCIPIO

REVISED

The following are the specs for the building Tannehill Fire Dept. wishes to build:

60' X 70' Pole barn type building with 14' sidewall height

- 4 each 12' X12' insulated steel overhead doors, all on one side. 70' Direction

1 each 3'0" X 6'8" walking steel door

6" concrete reinforced slab 60'X70'

Building is to be insulated with 2" commercial grade insulation

Post will be treated 6 X 6 10 ft. OC

- 26 Gauge colored metal

Metal will attached with screws- No nails

Top plate will be double 2 X 12

- Trusses will be 2 X 6, 5' OC maximum, 4/12 pitch, tied together with 2 X 4 stringers at the bottom

Girts will be 2 X 6

Purlins will be 2 X 4

NO Skylights

Building will be pre-engineered with drawings

Rough IN plumbing and electrical will be provided prior to concrete work by Tannehill Fire Dept.

- Note: This is a change from the original specs that were sent out
