


THEREFORE, each competitive bid submitted to the County must be accompanied with an affidavit for filing with the competitive bid form, as required by 61 O.S. § 138.



Project Description: Furnishing and driving 6-40' long 10"x42# steel piling, furnishing and setting 1-24' long 12"x63# steel cap, furnishing and welding 11-12"x12"x1/4" steel plates under existing beams on steel cap.
