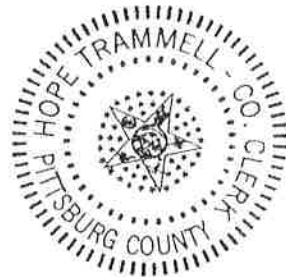




Bid specs for converting a M1078 LMTV military truck into a fire fighting brush truck

Truck is to be built in 7 phases with payment to be rewarded upon completion of each phase and approved by both of Savanna`s procurement officers Don Capps and Israel Pickens.

Savanna Fire Department will provide fire pump, Scotty foam system, radio, flash lights with chargers, running lights, warning lights, work lights, wire, float pump, hose reels 1 inch and ½ inch, all hoses hydrant wrench set, nozzles, and hand tools to be mounted inside truck boxes.

PHASE 1

Remove all unnecessary equipment to take truck to a cab and chassis configuration. Relocating any system that is impending fire fighting operations and relocating any system needed for truck operation. Example is the air over hydraulic controls for cab lift.

PHASE 2

Build water tank made of 3/16 steel plate, with removable top to hold 510 gallons of water. Tank size should measure 48 ½ inches wide 78 inches long and 30 ¼ inches tall with a 28 inch by 24 inch tapered sump towards front of tank. Tank to be coated with potable water liner. Tank to be fitted with all necessary outlets for water fill and water discharge to pump and necessary vents. Tank is to be baffled. A 1inch sight glass installed that is visible from firefighter platform. Tank to be mounted to brackets that will be welded to frame.

PHASE 3

Build a walk thru cross over behind cab made of 11 gauge plate steel. Doors with latches to be made for both ends of walk over. 1 and 1/4 inch black pipe is to be used to frame out doors and covered with expanded metal. Steps to be manufactured on both sides for easy entry. Hand rails of 1 and 1/4 black pipe for safety and ease of entry. A tool box to be made and mounted to passenger side 42 inch by 24 inch by 24 inch of 11 gauge metal. A sliding back glass to be installed in cab for visual and audio Como with driver and firefighter. Window to be similar to window in camper.

PHASE 4

Build side storage boxes for both sides of truck to measure 10 feet long 5 feet tall and 25 inches deep. Sides are to incorporate wheel wells and all storage box doors and latches made of 11 gauge metal. Pump plate to be mounted on driver side and constructed of heavier material of 3/16 plate. Safety rail to go around top of boxes to provide protection for work lights. Rails to be constructed of 1 and ¼ pipe. Brackets to be manufactured and welded to frame for box installation.

PHASE 5

Build front and rear bumpers with 4 inch pipe and 3/16 diamond plate, creating tow holes in bumper and manufacturing necessary brackets for attachment to frame. Build grill guards and windshield guard insuring that cab tilt and other access needed to gain truck access is not impeded.

PHASE 6

Install fire pump and plumb the tank to the pump. Install ½ inch hose reel in the walk thru, install 1 ½ for whip line in cross over and 1 inch hose reel at rear of truck and have all connected to pump. Use a 4 bolt repairable ball valves. Ensure plumbing enables fire pump to draft. Have a Scotty foam system installed to pump. Install all lights for truck operations and work light, install all fire department equipment to include drip torches, radio, flash lights with chargers blowers, rakes, shovels, float pump , fill hoses and nozzles all of which to be provided by Savanna Fire Department.

PHASE 7

Break down unit and remove all necessary parts for priming and painting. Reinstall and make delivery of truck.
