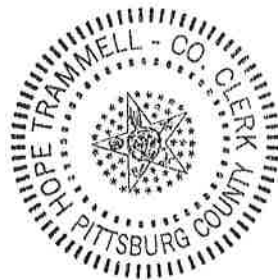

## Interior Room Plans for Blue FD Sta. #2

### Details

Furnish Materials and Labor for constructing 3 interior rooms inside Blue FD #2 per drawings.

Provide and Install—

- 1 – Electric Hot Water Heater (30) gal. Minimum
  - 1 - Double sink in Kitchen area with approximate 8' Cabinet
  - 1 - Electric Range (24) inch with vent hood & light
  - 1 - Shower Stall (32) inch Minimum
  - 1 - Vanity (32) inch with 18" sink
  - 1 - Elongated stool and seat
  - 1 - Wash Sink in Bay Area
  - 1 – Ceiling light in each room
  - 3 - Electrical Recept in office and kitchen rooms and 2 in bathroom.
- Install Flex duct to each room from exiting system. 2-8" & 1-6".
- 2 – 3'-0" interior doors
  - 1 - 2'X4' sliding window or Approximate size.
  - 1 – 5', expanding door for opening into Kitchen.

Finish inside walls with sheetrock and fur our with 2"x 2", on existing building walls on south and east and finish with 4'X 8'X ½" plywood or similar material.

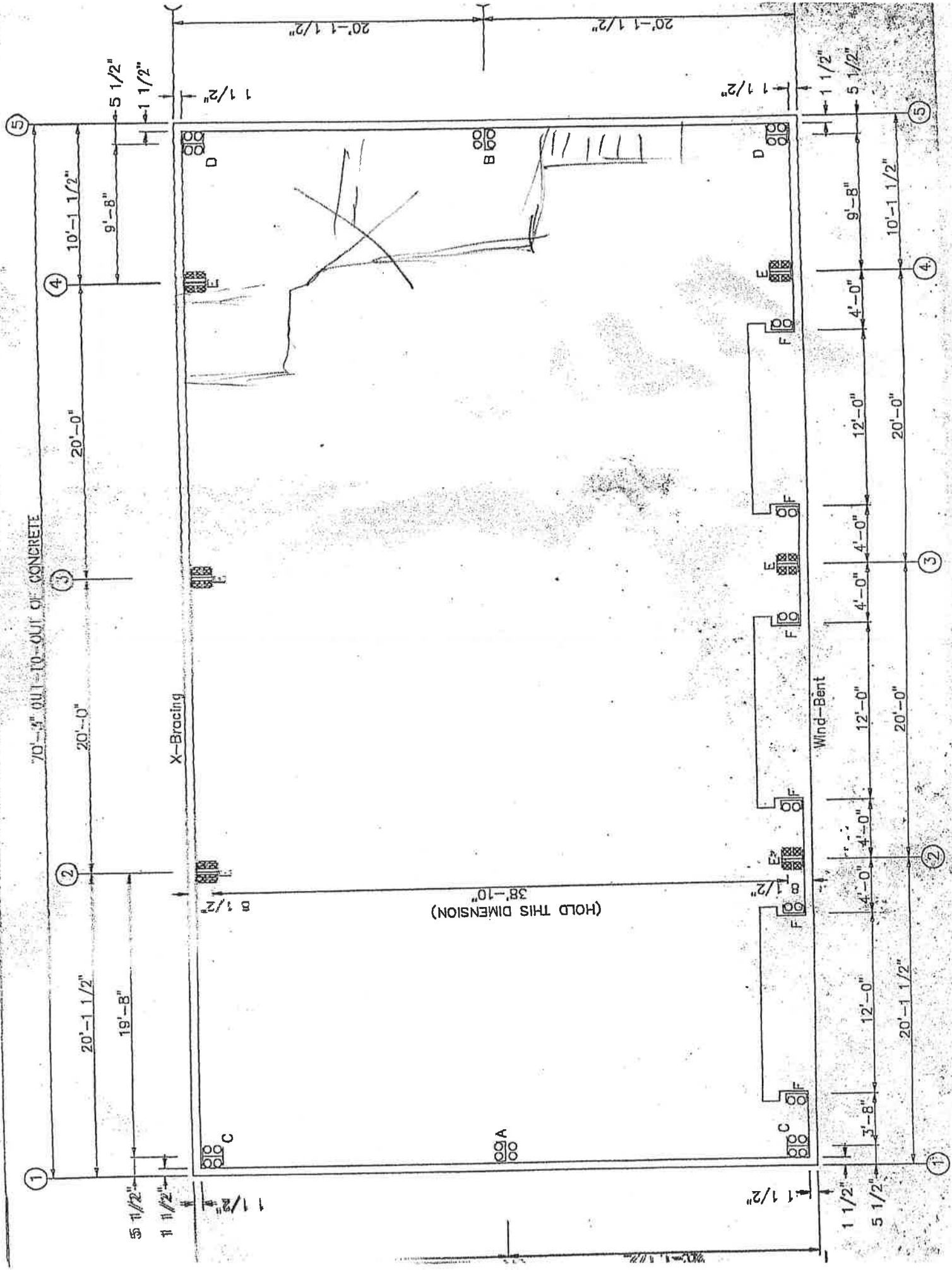
Insulate stud walls.

Finish outside walls with 4' X 8 X 1/2" plywood or similar material, trim with 1"x4" wood and stain as required.

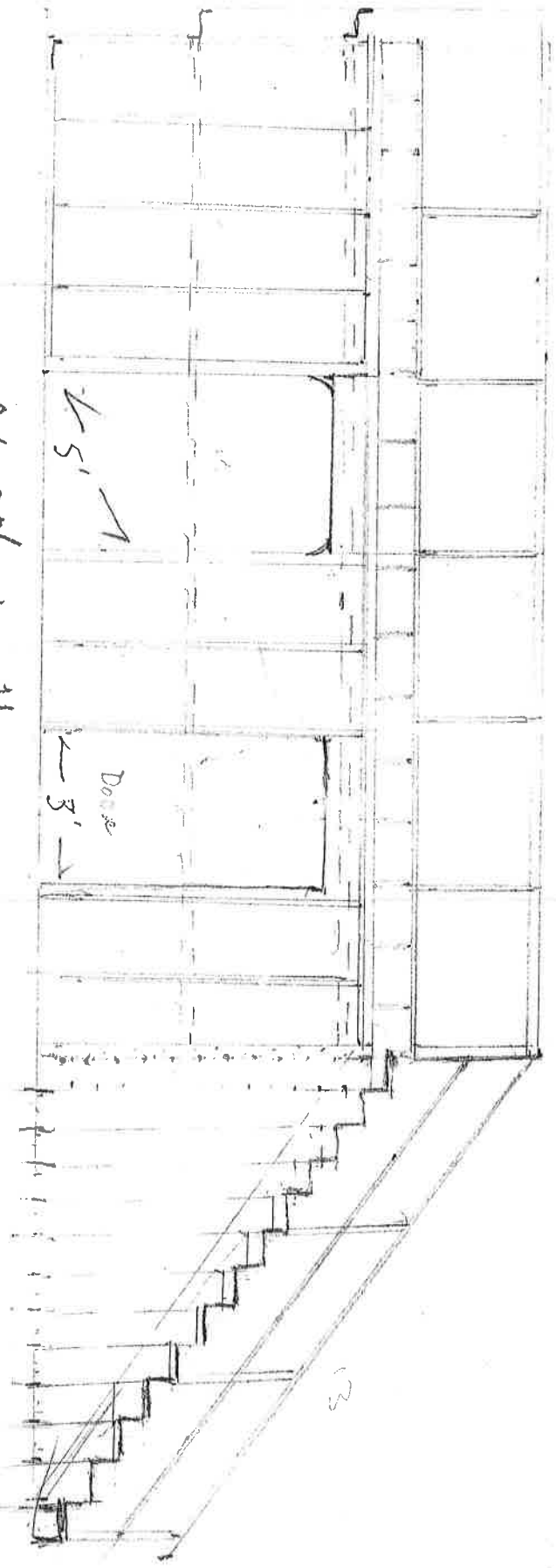
Note: outside walls will extent to 12' height.

Ceiling joist- 2"X 10"- deck with ¾" plywood or similar material.

Note: Furnish and install Plumbing and Electrical from existing services in building.

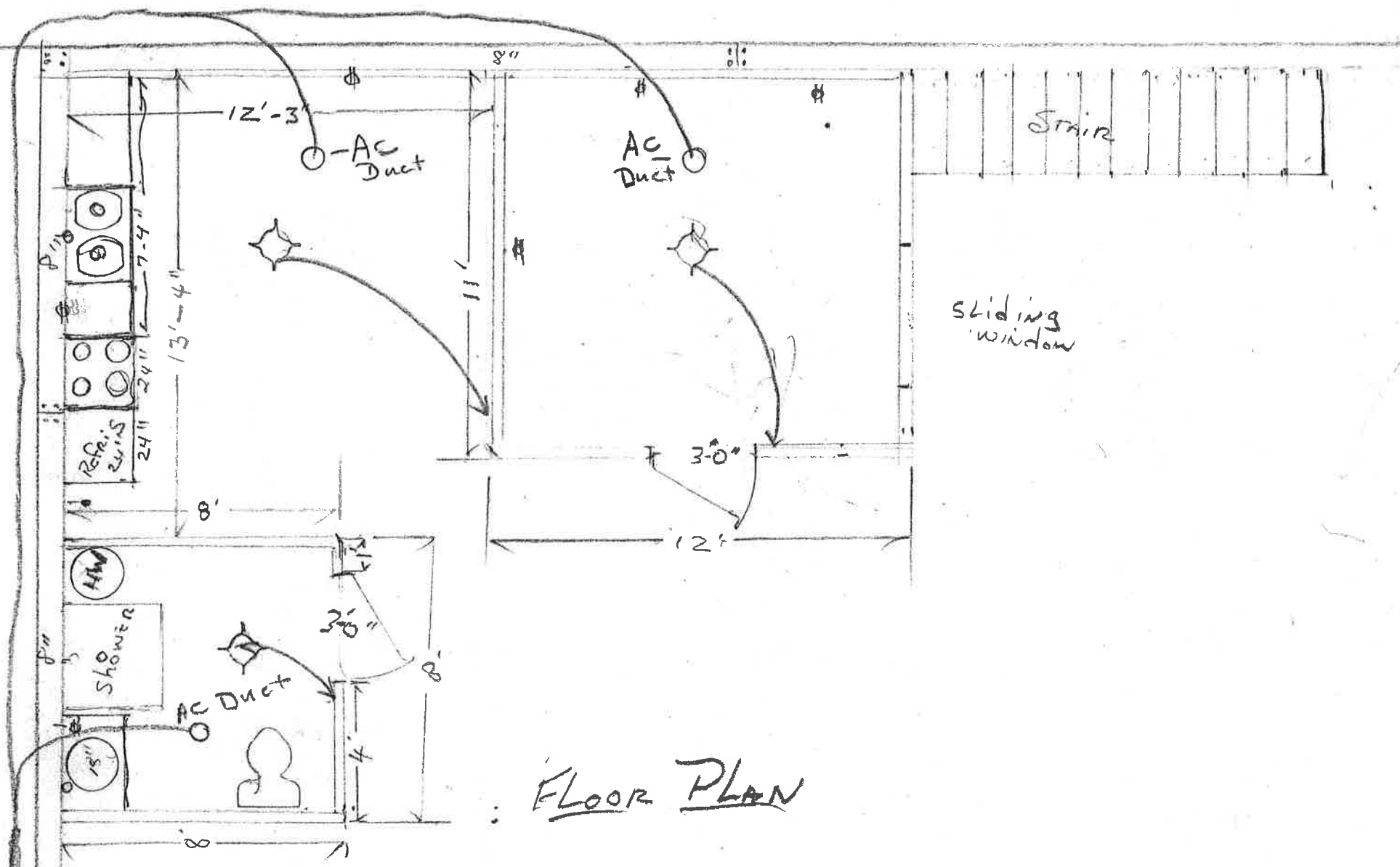


North Wall

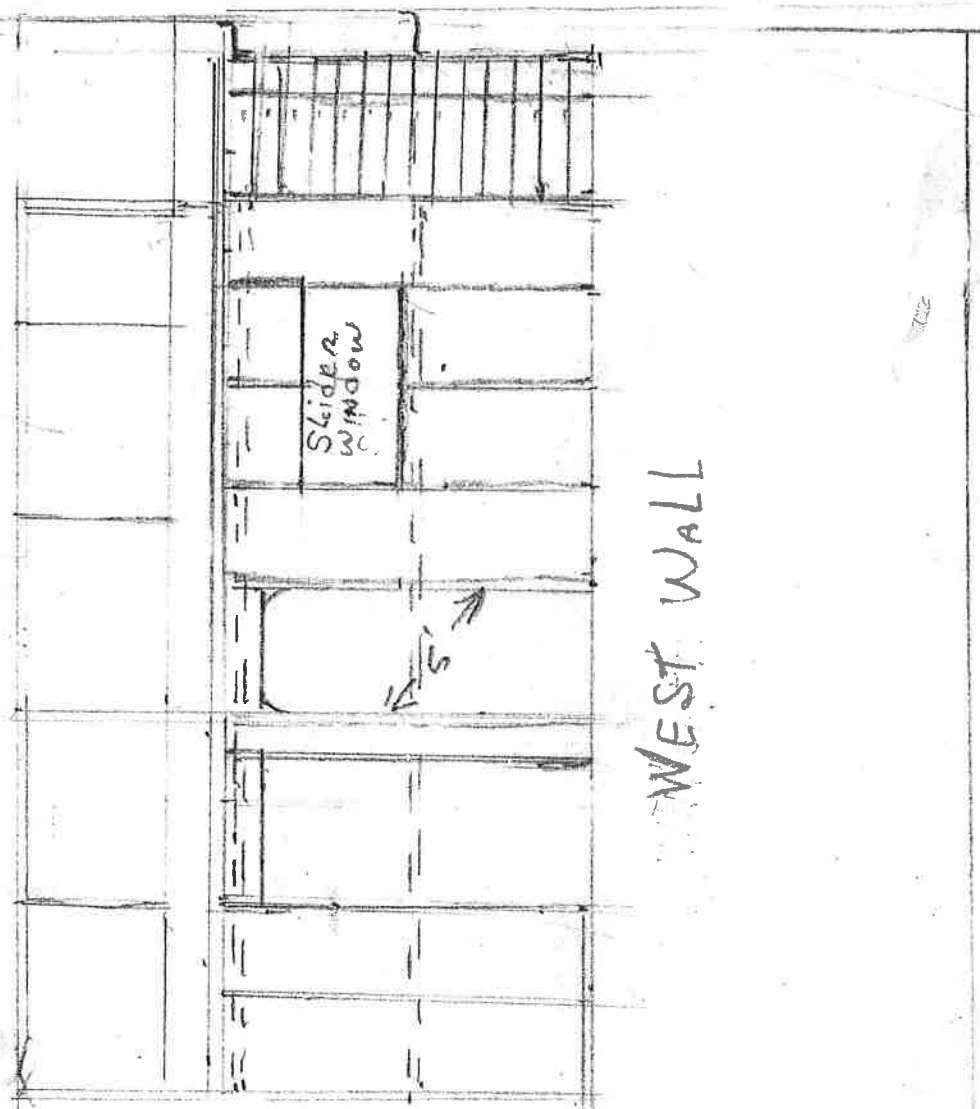


FLOOR PLAN
