

The Shady Grove VFD wishes to have a bid placed for a pumper meeting the minimum following criteria:

- 1 To have less than 25,000 miles
- 2 Pumper shall be a 1988 model or newer
- 3 Shall have an Automatic Transmission
- 4 Water tank capable of carrying 1,500 Gallons or more
- 5 Tires purchased in 2013 or newer
- 6 Pump delivery rate shall be a minimum of 1,500 rpm at 150 psi and have a recent pump certification of May 2015 or later.
- 7 Shall have a Foam Tank capable of carrying 30 gallons of foam or more.
- 8 A Deck Gun capable of delivering 1000 GPM. Shall all have Straight bore tips, with ground base.
- 9 Shall be equipped with an emergency Light Bar and a Siren that may be either electronic or mechanical
- 10 A minimum of 4 SCBA Seats
- 11 An aluminum 28' Extension Ladder, an aluminum 14' Roof Ladder and an Attic Ladder, all of which have been Service tested in 2012 or earlier
- 12 A minimum of 3 each Draft/Hard Suction Hoses 6" Diameter
- 13 Floating Drafting Strainer
- 14 Discharges: (1) 6 inch Jet Dump, (1) 3.5 inch, (5) 2.5 inch, (2) 1.75 inch
- 15 Intakes: (2) 2.5 inch, (2) 6 inch
- 16 Intake valve: (1) 6 inch Piston valve
- 17 Mid Shift/Top Mount Pump Controls
- 18 A minimum of 2 Scene Lights
- 19 Am Inverter producing 120 VAC with an output of 2200 watts or more
- 20 A minimum of 4 Rechargeable Flash Lights mounted on truck
- 21 Pike Poles: (1) 6ft, (1) 8ft
- 22 Ready to use upon arrival
