

_____ 3,000 GALLON TANK MANUFACTURED OF 1/4" CARBON STEEL ORIENTED TO BE MOUNTED VERTICALLY.

_____ TANK TO BE INSULATED WITH 3" THICK FOIL BACKED FOAM, AND THEN COVERED WITH ALUMINUM SHEETING FOR WEATHER PROTECTION AND SECONDARY CONTAINMENT. BOTTOM OF TANK TO BE FLAT.

_____ TANK IS ATTACHED TO STEEL SUPPORT STAND, WHICH IS INCLUDED, THAT PLACES THE TANK LOADING VALVES AT THE PROPER HEIGHT (5'6" ABOVE THE CONCRETE PAD) FOR GRAVITY FLOW LOADING OF THE EQUIPMENT.

_____ ACCESS LADDER WHICH GIVES EASY ACCESS TO THE TOP OF THE TANK. TOP OF TANK IS FITTED WITH AN INSPECTION DOOR. LADDER MUST BE CAGED FOR SAFETY AND TANK WILL HAVE SAFETY RAILING AROUND THE TOP. MUST HAVE 24" SIDE ACCESS DOOR.

_____ TANK TO BE EQUIPPED WITH 4 - 1000 WATT 240 VOLT SINGLE PHASE HEATER BLANKETS, WHICH WILL BE CONTROLLED BY AN ADJUSTABLE THERMOSTAT THAT IS ACCESSIBLE FROM GROUND LEVEL. ALL ELECTRICAL COMPONENTS ARE COMPATIBLE FOR INDOOR OR OUTDOOR SERVICE. INTERNAL HEATING ELEMENTS OR BURNERS UNACCEPTABLE.

_____ TANK IS EQUIPPED WITH TWO 3" BALL VALVES FOR LOADING AND UNLOADING THE TANK. THIRD VALVE ON BOTTOM OF TANK FOR EASH CLEAN OUT. THESE VALVES ARE WRAPPED WITH 240 VOLT HEAT TAPE AND THEN INSULATED TO AID IN COLD WEATHER OPERATIONS. VALVES ALSO HAVE PROVISIONS TO ACCEPT A PADLOCK FOR ADDED SECURITY.

_____ TANK TO INCLUDE A 7' LONG 3" DIAMETER HEAVY DUTY RUBBER LOADER HOSE FITTED ON ONE END WITH A QUICK COUPLER WHICH MATES TO THE LOADING/UNLOADING VALVES, AND THE OTHER END TO BE FITTED WITH A STEEL 90 DEGREE ELBOW FITTING.

TANK INCLUDES A MECHANICAL PADDLE TYPE AGITATION SYSTEM, WHICH IS AUTOMATICALLY CONTROLLED BY A PROGRAMMABLE AGITATION TIMER, WHICH IS INCLUDED IN THIS PROPOSAL. TIMER WILL BE PRE-PROGRAMMED AT THE FACTORY. AGITATOR SHOULD NOT TURN AT A RATE EXCEEDING 6 RPM TO AVOID WHIPPING THE EMULSION AND CAUSING SEPARATION.

TANK INCLUDED A MATERIAL QUANTITY GAUGE, EASILY VIEWED FROM GROUND LEVEL, CALIBRATED IN 100 GALLON INCREMENTS.

TANK AND ITS COMPONENTS TO HAVE 1 YEAR WARRANTY; EXCLUDING THE CONCRETE PAD, INCOMING ELECTRICAL SERVICE INSTALLATION, AND COMPONENTS, WHICH ARE SUPPLIED BY INDEPENDENT CONTRACTORS HIRED BY THE USER AGENCY (CUSTOMER).

SELLER TO PROVIDE A FACTORY TRAINED REPRESENTATIVE TO ASSIST IN THE INSTALLATION AND FINAL OPERATIONAL PREPARATIONS TO READY THE TANK FOR OPERATION. THIS REPRESENTATIVE WILL ALSO PROVIDE COMPLETE OPERATION AND MAINTENANCE TRAINING TO THE CUSTOMER.
