

Criteria For Side BY Side / ATV

Location: Russleville Area Volunteer Fire Department

Date: 9/1/2018

Purpose of Side by Side: Would be for fighting and surveying fires in terrain not suitable for our brush trucks and to aid in recovery of fire fighters.

Engine Requirements minimum:

- *999cc
- *water cooled

Transmission Requirements:

- *Three speed Automatic
- *Manuel paddle shift / Fully Automatic

Steering Requirements:

- *Power Steering

Towing/Payload Requirements minimum:

- *1500lb towing
- *1000lb hauling

Ground Clearance minimum:

- *12"

Drive Train Requirements:

- *4WD with Differential lock
- *Direct front and rear driveshaft

Tire Requirement Minimum:

- *10 ply

Winch Requirements:

- *3500lb

Additional Equipment:

- *Half windshield
- *Top
- *24" led light bar
