CRITERIA FOR UTV/WILDLAND FIRE APPARATUS

Location: Krebs Volunteer Fire Department

- New 2024 or newer
- Engine Requirements: Liquid Cooled, 1498cc Engine displacement, 110HP, 4 stroke, Electronic Fuel Injection
- Steering Requirements: Electronic Power steering
- Towing/Payload Requirements: 1500lb Bed Capacity, 3500lb Towing Capacity, 1705lb Payload Capacity
- Ground Clearance Minimum: 15 Inch
- Cab Requirements: Premium Pro-Shield Cab, Doors with full Power windows, tip-out glass windshield with wiper, rear glass panel, HD 6,000lb winch with auto stop and wireless remote.
- Vehicle Color: Red
- Vehicle Lighting: LED headlight w/LED Headlamps. Also unit will be equipped with blinkers, horn, tag light, rear view mirror, and side mirrors
- Suspension: Rear suspension to be upgraded for more cargo capacity.
- HVAC/HEATING: Cab to have heat and air conditioning.
