

Sealed bids will be opened during a meeting of the board of county commissioners

The board of county commissioners will accept the highest bid, if bids come in at or over the determined value of the vehicle.

If all bids come in under the determined value of the vehicle, the board is required by law to re-bid.

Commissioners will re-advertise for bids and give no less than another 21 days from first day of advertising before bids are due.

Sealed bids will once again be opened during a meeting of the board of county commissioners.

This time the board of county commissioners will accept the highest bid regarding of amount offered.
