All Deliveries are requested on a weekly basis and should always fall on the same day of the week. On holiday weeks, if a day must be changed, please notify the office the week before of the day change so that we may continue to follow proper purchasing procedures.

Initial set up for all services must be approved by the County Commissioner. Highway District orders will be handled at the District shops as outlined above. Courthouse, Animal Shelter and Extension Center initial orders can be handled at the Courthouse during the set up process. Vendor is responsible for making the proper appointments by calling the Board of County

Commissioners office upon awarding of bid. Uniform Color and types will be at the discretion of the County Commissioner.

Uniforms will be replaced as needed or no less than every 24 months. Each County Commissioner should have the authority to request uniform replacement when item is deemed "worn out" by the Commissioner or when an item is damaged severely enough that repairs are unfeasible. When an employee leaves, uniform buy back should be pro-rated based on how old the uniforms are. Example: If an employee wears a uniform for one year and leaves the employment of Pittsburg County, no more than 50% of the original cost of the uniforms will be charged.

All prices prepared for this bid should be prepared at a weekly price, except for initial setup fee for emblems. Bid Prices are not subjected to change without prior approval from the Board of County Commissioners. Price increases must be made in writing to the Board of County Commissioners in advance with notice of no less than one month.

Contract will be for one year from the date awarded. Vendor will be required to provide the necessary paperwork to the Board of County Commissioners before the contract expiration date of each year and may be approved by the Board in yearly increments up to four (4) consecutive years at the Board's discretion.
