Bugtussle Fire Department is out for bid to have built and install equipment to make a 2008 Freightliner Truck fully functional to haul, dump, and pump water for firefighting activities.

Truck is being supplied by department:

2008 Freightliner with GVWR 69,480 lbs

Truck was Military provided to department by Oklahoma Forestry

Supplied truck is to be equipped as follows:

- 1) 3000 Gallon Tank
 - 3/16 Shell, Dished Heads, 2 baffles
 - (2) - 3" Rear Fill lines, one on either side of ladder
 - (2) – Manifolds with (2) 2 ½" and (2) 1 ½" Ball-valves – installed
(Drivers Side and Passenger Side)
- Steps
- Full Length Hose trays on both sides
- Side Spray Assembly: (2) – Inline Valves, (2) Side Spray Heads, (4) VIC Clamps or equivalent
- (2) 5"x7" Brackets on both sides of tank and rear of tank up high in corner area, for emergency lighting, with wire chase way or equivalent mount
- 1) Control Box in Cab – 4 switches minimum or equivalent
- 1) Pump rated at minimum of 750 gpm or bigger
- 1) Epoxy Coating inside of tank or equivalent rust protection
- 1) Dump Valve Flange on rear of tank
- 1) 10"x10" Air or Electric Dump Valve Controlled from Cab, with swivel chute capable of 2000 gpm minimum, (ie, Newton 6012SW) or equivalent
- 1) Drop Tank Between Tank and Cab Minimum capacity of 3000 Gallons
- 1) Paint Cab F1 Red, Paint Tank F1 Red, Black Out Frame and Paint Wheels Black
