The Pittsburg County Election Board met in a special meeting at 10:00 a.m. in Room 101 of the Pittsburg County Courthouse annex. Advance notice of the meeting was performed by filing a written notice with the County Clerk on October 26, 2016 at 2:19 p.m. and posting an agenda at the County Election Board on October 26, 2016 at 2:30 p.m. One copy of each of the notice and agenda is attached.

The following members were present: Beulah Stacks, Chairman; Ted Kennedy, Vice Chairman and Cathy Thornton, Secretary.

The meeting was called to order at 10:00 a.m. by Ms. Stacks.

BUSINESS CONDUCTED AT THE MEETING

- 1. BUSINESS CONDUCTED: Discuss and approve minutes of the meeting held August 26, 2016. ACTION TAKEN: Ms. Stacks moved that the minutes for the meeting held August 26, 2016, be approved with the following note: Had to call a special meeting in order to open outer envelopes and examine the affidavits for sufficiency and removing the affidavit envelopes for the General Election 11-8-16. Mr. Kennedy seconded the motion. ROLL CALL VOTE: Ms. Stacks yes; Mr. Kennedy yes; Mrs. Thornton yes. Motion passed 3-0.
- 2. BUSINESS CONDUCTED: Process mail absentee ballots submitted for the November 8, 2016, General Election. Including opening outer envelopes and examining the affidavits for sufficiency, removing the affidavit envelope. ACTION TAKEN: The Board members opened outer envelopes and examined the affidavits.

The Board determined that eleven ballots received by mail could not be counted. Two affidavits had not been properly witnessed by two persons as required by law, five ballots could not be counted because the affidavits had not been properly notarized by a notary as required by law, two ballots did not have an affidavit, one affidavit had not been signed by the voter and one affidavit had not been filled out at all.

August 26, 2016

The Pittsburg County Election Board met in a regular meeting at 1:00 p.m., in Room 101 of the Pittsburg County Courthouse annex. Advanced notice of the meeting was performed by filing a written notice with the County Clerk on November 17, 2015 at 10:29 a.m. and posting an agenda at the County Election Board office on August 15, 2016, at 2:35 p.m. One copy of each of the notice and agenda is attached.

Due to the lack of quorum at 1 p.m. the meeting did not convene until 4:12 p.m. At that time the following members were present: Beulah Stacks, Chairman; Ted Kennedy, Vice Chairman and Cathy Thornton, Secretary.

The meeting was called to order at 4:12 p.m. by Mr. Kennedy.

BUSINESS CONDUCTED AT THE MEETING

- 1. BUSINESS CONDUCTED: Discuss and approve minutes of the meeting held August 23, 2016. ACTION TAKEN: Mr. Kennedy moved that the minutes for the meeting held August 23, 2016, be approved.
