The Board of County Commissioners, Pittsburg County, met in emergency session on May 20, 2025 at 4:00 P.M., Meeting held in County Commissioners Conference Room, after proper notice and agenda were posted indicating time and date. Agenda was posted at 3:12 P.M., May 20, 2025.

B. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION TO SET DEBRIS DISPOSAL SITE FOR DEBRIS REMOVAL:

Haynes stated asked if the area behind the feed store in Kiowa would be permissible. Jonathan Schulz with DEQ stated that the site cannot be used if the debris is going to be burned if a residence is located within 500 feet. Leo Baughman suggested using the City of McAlester mulch site at the landfilled. Haynes asked if the debris can be placed on private property. Schulz stated that we have to be able to capture the debris totals for reimbursement and that it cannot be placed in a floodplain and the property would have to be checked for archaeological and tribal before it can be used. Baughman asked how long it will take to get approval from OEM. Haynes suggested several locations. Schulz stated that they can view the sites in the morning and that there will need to be a lease if it is located on private property. Schulz also stated that they will have 90 days to have the debris disposed of. Schulz and Baughman stated that they will meet at the District 2 yard at 8:00 in the morning. No action taken.

DISASTER EMERGENCY DECLARATION

WHEREAS, On May 19th, 2025, having occurred in Pittsburg County, -0- fatalities and _____ injuries, with considerable damage to public and private properties; and

WHEREAS, immediate attention is required to protect public health, reduce further damage, insure public safety and render emergency relief due to Severe storms and tornadoes.

WHEREAS, I, Charlie Rogers, Chairman of the Board of County Commissioners of Pittsburg County, Oklahoma, do find that the aforementioned conditions constitute a threat to the safety and welfare of the county, and create an emergency disaster situation within the meaning of Section 683.3, Oklahoma Emergency Management Act of 2003, as amended.

NOW, THEREFORE, I, Charlie Rogers, Chairman of the Board of County Commissioners, Pittsburg County, acting under the power vested in me under Pittsburg County do hereby declare Pittsburg County to be a disaster area, entitled to aid, relief and assistance and do hereby direct the implementation of the County/City Emergency Operations Plan.


