**A. DISCUSSION CONSIDERATION AND POSSIBLE ACTION REGRDING
EMPLOYEE HEALTH INSURANCE OPTION FOR FFISCAL YEAR 2026-2027:**

Rogers stated that they are waiting on updated information from OPEH&W. Trammell stated that Gallagher presented Community Care which is not widely accepted here. Ridenour asked about prescriptions changing. Haynes stated that all of the options are close in range but are a lot more expensive than federal employee and retiree insurance.

Trammell explained the Surist option that was presented by NFP, stating that the plan allows you to pick where you want to go but the costs will vary by provider choice. The board discussed OPEH&W assessments. Trammell stated that everyone needs to review all of the options available and revisit the issue next week.
