Cook stated that he was able to negotiate the rate pass as well as a decrease to the specialist copay to \$40.00 per visit. Selman asked about the different copays. Cook explained. Cook stated that on the dental we will also have a rate pass and that the he was able to raise the maximum per year to \$2,000.00 for \$1,500.00. Rogers asked about braces. Cook stated that the orthodontics will pay \$1,500.00. Cook stated that the vision rates will increase by \$1.47 per employee a month, \$1.29 for spouse, \$1.37 per child. Cook stated that he is still negotiating the vision rates. Selman asked about Lasik surgery. Cook stated that those services receive a discount.

Cook stated that the life rates will be staying the same and explained that age reduction schedule. Selman asked about the changing the age reductions. Cook stated that usually they are reduced at 65 and again at 75, however they have been extended to 70 and 80 and that he is trying to get them extended another 5 years. Rogers asked about open enrollment. Cooks stated that it will be in May. Smith made a motion to move forward with the renewal process; seconded by Selman.
