

MINUTES FOR THE
PITTSBURG COUNTY ELECTION BOARD MEETING

February 16, 2018

The Pittsburg County Election Board met in a regular meeting at 1:00 p.m., in Room 101 of the Pittsburg County Courthouse annex. Advanced notice of the meeting was performed by filing a written notice with the County Clerk on November 29, 2017 at 2:20 p.m. and posting an agenda at the County Election Board office on January 29, 2018, at 4:10 p.m. One copy of each of the notice and agenda is attached.

Due to the lack of quorum at 1 p.m. the meeting did not convene until 3:00 p.m. At that time the following members were present: Beulah Stacks, Chairman; Ted Kennedy, Vice Chairman.

The meeting was called to order at 3:00 p.m. by Ms. Stacks.

BUSINESS CONDUCTED AT THE MEETING

1. **BUSINESS CONDUCTED:** Discuss and approve minutes of the meeting held February 13, 2018. **ACTION TAKEN:** Mr. Kennedy moved that the minutes for the meeting held February 13, 2018, be approved. Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes. Motion passed, 2-0.

2. **BUSINESS CONDUCTED:** Receive and count verified provisional ballots. **ACTION TAKEN:** Assistant Secretary Barnes stated that 16 provisional ballots were cast in 11 precincts on Election Day and In-Person. The information provided on 8 of the 16 provisional ballot affidavits was verified by County Election Board personnel and those ballots have been approved for counting. The other 8 provisional ballots were rejected because four voters were registered to vote in the wrong school district, three were not registered and one went to wrong precinct on Election Day. Ms. Stacks made motion to accept and count the 8 verified provisional ballots. Mr. Kennedy seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes. The motion passed 2-0. The Board members then followed established procedures to prepare the ballots for counting. The Board members observed while the County Election Board Chief Clerk Carla Morris scanned the ballots through the eScan voting device to count them. The Board examined tabulation reports and unofficial certification reports.

3. **BUSINESS CONDUCTED:** Recess meeting. Recess not necessary. **ACTION TAKEN:** None. Board action not required.


Cathy Thornton, Secretary joined the meeting at 3:30 p.m.

4. BUSINESS CONDUCTED: Certify the February 13, 2018, Annual School Election Board of Education member returns for the following school districts totally contained in Pittsburg County (single county districts) or for which Pittsburg County Election Board is the parent County Election Board: Canadian I-2, Haileyville I-11, Hartshorne I-1, Kiowa I-14, McAlester I-80 and Pittsburg I-63. ACTION TAKEN: Ms. Stacks moved that the final election results be certified for the Annual School Election Board of Education member returns. Mr. Kennedy seconded the motion. ROLL CALL VOTE: Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)
5. BUSINESS CONDUCTED: Certify the February 13, 2018, Annual School Election Board of Education member returns for the following school districts for which the Pittsburg County Election Board is an affected County Election Board: Clayton I-10 certified to the Pushmataha County Election Board. ACTION TAKEN: Ms. Stacks moved that the final election results be certified for the Annual School Election Board of Education member returns for Clayton I-10 certified to the Pushmataha County Election Board. Mr. Kennedy seconded the motion. ROLL CALL VOTE: Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)
6. BUSINESS CONDUCTED: Certify the February 13, 2018, Special Election (1 proposition) for Savanna Public School District I-30. ACTION TAKEN: Mr. Kennedy moved that the final election results be certified for the Special Election (1 proposition) for Savanna Public School District I-30. Ms. Stacks seconded the Motion. ROLL CALL VOTE: Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)
7. BUSINESS CONDUCTED: Certify the February 13, 2018, Special Election (4 propositions) for the City of McAlester. ACTION TAKEN: Mr. Kennedy moved that the final election results be certified for the Special Election (4 propositions) for the City of McAlester. Ms. Stacks seconded the motion. ROLL CALL VOTE: Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)

8. BUSINESS CONDUCTED: Discuss dates and times for future County Election Board meetings. Secretary Thornton informed the members that the next County Election Board meeting is expected to be held April 3, 2018, at 10:00 a.m. in connection with the 2018 Annual School Runoff, City of McAlester Primary and City of Hartshorne Special Elections.
9. BUSINESS CONDUCTED: Adjourn meeting. ACTION TAKEN: Ms. Stacks moved to adjourn until next meeting which is scheduled on Tuesday, April 3, 2018 at 10:00 a.m. Mr. Kennedy seconded the motion. ROLL CALL VOTE: Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed, 3-0. The meeting adjourned at 5:05 p.m.




