

MINUTES FOR THE
PITTSBURG COUNTY ELECTION BOARD MEETING

April 5, 2019

The Pittsburg County Election Board met in a regular meeting at 1:00 p.m., in Room 101 of the Pittsburg County Courthouse annex. Advanced notice of the meeting was performed by filing a written notice with the County Clerk on December 3, 2018 at 2:28 p.m. and posting an agenda at the County Election Board office on March 29, 2019, at 2:15 p.m. One copy of each of the notice and agenda is attached.

Due to the lack of quorum at 1 p.m. the meeting did not convene until 3:30 p.m. At that time the following members were present: Beulah Stacks, Chairman; Ted Kennedy, Vice Chairman, Cathy Thornton, Secretary.

The meeting was called to order at 3:30 p.m. by Ms. Stacks.

BUSINESS CONDUCTED AT THE MEETING

1. **BUSINESS CONDUCTED:** Discuss and approve minutes of the meeting held April 2, 2019. **ACTION TAKEN:** Mr. Kennedy moved that the minutes for the meeting held April 2, 2019, be approved. Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed, 3-0.

2. **BUSINESS CONDUCTED:** Receive and count verified provisional ballots. **ACTION TAKEN:** Assistant Secretary Barnes stated that 10 provisional ballots were cast in 2 precincts on Election Day and In-Person. The information provided on 4 of the provisional ballot affidavits was verified by County Election Board personnel and were approved for counting. The other 6 provisional ballots were rejected because 4 voters were not a registered voter on Election Day and 2 went to the wrong precinct to vote. Mr. Kennedy made motion to accept and count 4 verified provisional ballots. Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. The motion passed 3-0. The Board members then followed established procedures to prepare the ballots for counting. The Board members observed while the County Election Board Chief Clerk Carla Morris scanned the ballots through the eScan voting device to count them. The Board examined tabulation reports and unofficial certification reports.

3. **BUSINESS CONDUCTED:** Recess meeting if necessary and reconvene no later than 4.30 p.m. in the same location. **ACTION TAKEN:** Mr. Kennedy moved that the Board recess its meeting and reconvene at 4:30 p.m. in the County Election Board office. Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes ; Mrs. Thornton – yes. Motion passed 3-0.

The meeting was reconvened at 4:30 p.m. in the County Election Board office and called back to order by Ms. Stacks. All members were present.


4. **BUSINESS CONDUCTED:** Certify the April 2, 2019, Regular Municipal General Election for the statutory municipalities totally contained within Pittsburg County: City of Haileyville, City of Hartshorne and Town of Kiowa. **ACTION TAKEN:** Mr. Kennedy moved that the final election results be certified for the Regular Municipal General Elections. Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)
5. **BUSINESS CONDUCTED:** Certify the April 2, 2019, Board of Education General Election returns for the following school districts totally contained in Pittsburg County (single county districts) or for which Pittsburg County Election Board is the parent County Election Board: Indianola I-25 and Krebs C-9. **ACTION TAKEN:** Mr. Kennedy moved that the final election results be certified for the Board of Education General Election returns. Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)
6. **BUSINESS CONDUCTED:** Certify the April 2, 2019, Board of Education General Election returns for the following districts for which the Pittsburg County Election Board is the affected County Election Board: Clayton to Pushmataha County Election Board. **ACTION TAKEN:** Mr. Kennedy moved that the final election results be certified for the Board of Education General Election returns. Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)
7. **BUSINESS CONDUCTED:** Certify the April 2, 2019 for the City of McAlester Special (councilman ward 5) a home rule charter municipality totally contained within Pittsburg County. **ACTION TAKEN:** Mr. Kennedy moved that the final election results be certified for the City of McAlester Special (councilman ward 5). Ms. Stacks seconded the motion. **ROLL CALL VOTE:** Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed 3-0. (One copy of the Official Certification Report is attached hereto and incorporated herein.)

8. BUSINESS CONDUCTED: Discuss dates and times for future County Election Board meetings. Secretary Thornton informed the members that the next County Election Board meeting is expected to be held May 1, 2019, at 10:00 a.m.
9. BUSINESS CONDUCTED: Adjourn meeting. ACTION TAKEN: Ms. Stacks moved to adjourn until next meeting which is scheduled on Wednesday, May 1, 2019 at 10:00 a.m. Mr. Kennedy seconded the motion. ROLL CALL VOTE: Ms. Stacks – yes; Mr. Kennedy – yes; Mrs. Thornton – yes. Motion passed, 3-0. The meeting adjourned at 5:04 p.m.
