



THE ELM POINT VFD AND PITTSBURG COUNTY WILL BE TAKING SEALED BIDS TO PURCHASE, TWO SELF CONTAINED BREATHING APPARATUS (SCBA) WITH FUNDS PROVIDED BY COUNTY FIRE TAX DOLLARS

1. TWO (2) SELF CONTAINED BREATHING APPARATUS WITH 2216 PSI CARBON CYLINDERS
2. PLUS THREE (3) MORE 2216 PSI CARBON CYLINDERS AND MUST BE ACCOMPANIED WITH AUXILLARY MOUNTING FOR SPARE TANKS
